AN ORDINANCE INCORPORATING THREE EXISTING MOBILEHOME PARKS, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO MOBILEHOME PARK OVERLAY ZONE, AS DEFINED BY SECTION 101.1001 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the following mobile home parks:

- 1. Dake's Trailer Court, 2370 Smythe Avenue, San Diego (portion Lots A286 and A287, Little Landers Addition No. 7, Map 1500);
- 2. Larson's Trailer Park, 2262 Smythe Avenue, San Diego (Lot A275, Little Landers Addition No. 7, Map 1500);
- 3. Las Lomas Mobilehome Park, 1819 Smythe Avenue, San Diego (portion Lot 65, Barrio San Martin, Map 7042); all in the City of San Diego, California, within the boundary of the district designated "Mobilehome Park Overlay Zone" on Zone Map Drawing No. C-672, filed in the office of the City Clerk as Document No. 768439, be, and they are hereby incorporated into the Mobilehome Park Overlay Zone, a such zone is described and defined by Section 101.1001 of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this

ordinance.
