AN ORDINANCE SETTING ASIDE AND DEDICATING PORTIONS OF CAMBRIDGE COLONY AND MANON TERRACE, TOGETHER WITH A PORTION OF PUEBLO LOT 1205, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "TECOLOTE CANYON NATURAL PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Parcels C and D of Cambridge Colony Unit No. 1, Lot 58 of Manon Terrace, together with a portion of Pueblo Lot 1205, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.


Section 2. That the hereinafter described real property be and the same is hereby named TECOLOTE CANYON NATURAL PARK.
