AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 86.23(d), RELATING TO PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VIII, Article 6, of the San Diego Municipal Code be and the same is hereby amended by amending Section 86.23(d) to read as follows:

SEC. 86.23 PARKING VEHICLES FOR SALE OR SERVICE PROHIBITED

(a) through (c)--no amendments to these paragraphs.

(d) No person who deals in or whose business involves the sale, lease, rental or charter of vehicles shall store, park or stand any such vehicle upon any public street except while such vehicle is under lease, rental, or charter by a customer. This Section shall not apply to vehicles regulated by Sections 75.0101 through 75.0603 of this Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

(a) through (c)--no amendments to these paragraphs.

(d) No person who deals in or whose business involves the sale, lease, ~~or~~ rental or charter of vehicles ~~or whose business involves the transportation of persons by motor vehicles as a charter party carrier of passengers,~~ shall store, stand or park any such vehicle upon any public street except while ~~the~~ such vehicle is ~~held for sale,~~ under lease, charter or rental by a customer. This section shall not apply to vehicles regulated by Sections 75.0101 through 75.0603 of this Code.

Section 2. This ordinance shall take effect and be in force  
on the thirtieth day from and after its passage.
