BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Chapter X, Article 1, Division 7 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0761 to read as follows:

SEC. 101.0761 TIME LIMITATION FOR ORDINANCE

This ordinance shall become effective upon passage and remain in force for two years therefrom unless repealed prior thereto.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
