AN ORDINANCE SETTING ASIDE AND DEDICATING PORTIONS OF BLOCKS 291, 297, 298, 299, 311, 312, 324, 325 AND 332 OF HORTON'S ADDITION, IN THE CITY OF SAN DIEGO, CALIFORNIA, FOR A PUBLIC PARK AND NAMING SAID PARK "MAPLE CANYON OPEN SPACE PARK."

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Blocks 291, 297, 298, 299, 311, 312, 324, 325 and 332 of Horton's Addition, which are more particularly described in Attachment A hereto which is by this reference incorporated herein, are hereby set aside and dedicated in perpetuity for park and recreational purposes.


Section 2. That the hereinafter described real property be and the same is hereby named MAPLE CANYON OPEN SPACE PARK.
