AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 1, DIVISION 20, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 61.2004 AND 61.2044, RELATING TO THE SALE OF BONDS PURSUANT TO THE SAN DIEGO PARK FACILITIES DISTRICT PROCEDURAL ORDINANCE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter VI, Article 1, Division 20 of the San Diego Municipal Code be and it is hereby amended by amending Sections 61.2004 and 61.2044 to read as follows:

SEC. 61.2044 RATES OF INTEREST

Any provision of law to the contrary notwithstanding, bonds heretofore or hereafter authorized may be sold at private or public sale, at, above or below par, to bear

interest at the rate or rates per annum, without limit as
to rate or amount as provided in the accepted bid or
agreement for their purchase, as determined by the Council.
Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
