## ORDINANCE NUMBER 0-15783 (New Series)

## Adopted on JUL 26 1982

AN ORDINANCE PREZONING A PORTION OF LOTS 34 AND 36, RANCHO MISSION, AND A PORTION OF LOT 1, MAP NO. 875 (APPROXIMATELY 240 ACRES), LOCATED NORTH AND SOUTH OF FRIARS ROAD WEST OF SAN DIEGO JACK MURPHY STADIUM AND EAST OF 1-805, IN THE EAST MISSION VALLEY AREA PLAN; FROM COUNTY UNZONED PROPERTY IN THE COUNTY OF SAN DIEGO, CALIFORNIA, INTO R-1-40 ZONE AS DEFINED BY SECTION 101.0407, R-1-40 (FPF) ZONE AS DEFINED BY SECTION 101.0407 (101.0403.1), AND FW ZONE AS DEFINED BY SECTION 101.0403 OF THE SAN DIEGO MUNICIPAL CODE.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That a portion of Lots 34 and 36, Rancho Mission, and a portion of Lot 1, Map No. 875 (approximately 240 acres), located north and south of Friars Road west of San Diego Jack Murphy Stadium and east of I-805, in the East Mission Valley Area Plan, from County unzoned property, in the County of San Diego, California, within the boundaries of the district designated "R-1-40", "R-1-40 (FPF)" and "FW" on that certain Zone Map Drawing No. B-3490.1, filed in the office of the City Clerk under Document No. RR-768490, be, upon annexation to The City of San Diego, incorporated into R-1-40 Zone as defined by Section 101.0407, R-1-40 (FPF) Zone as defined by Section 101.0407 (101.0403.1) and FW Zone as defined by Section 101.0403, of the San Diego Municipal Code.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, or the effective date of such annexation to the City of San Diego.
