ORDINANCE NUMBER O- 15801 (New Series)

Adopted on AUG 9 1982

AN ORDINANCE INCORPORATING THE SOUTH 15 FEET OF LOT 7 AND ALL OF LOT 8, BLOCK 46, CITY HEIGHTS, MAP NO. 1007 (A 5,000 SQ. FT. SITE), LOCATED ON THE EAST SIDE OF 43RD STREET BETWEEN UNIVERSITY AND POLK AVENUES, IN THE MID-CITY DEVELOPMENT PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11604 (NEW SERIES), ADOPTED MAY 22, 1975, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That the south 15 feet of Lot 7 and all of Lot 8, Block 46, City Heights, Map No. 1007 (a 5,000 sq. ft. site), located on the east side of 43rd Street between University and Polk Avenues, in the Mid-City Development Plan area, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3528, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11604 (New Series), adopted May 5, 1975, of the ordinances of The City of San Diego be, and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this

ordinance.
