AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 34 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.3402, RELATING TO THE GAME OF BINGO.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Chapter III, Article 3, Division 34 of the San Diego Municipal Code be, and the same is hereby amended by amending Section 33.3402 to read as follows:

## SEC. 33.3402 DEFINITIONS

The following words and phrases, wherever used in this Division, shall be construed as defined in this section, unless from the context a different meaning is intended, or unless a different meaning is specifically defined and more particularly directed to the use of such words or phrases:

(a) "Bingo" shall mean a game of chance in which prizes are awarded on the basis of designated numbers or symbols on a card which conform to numbers or symbols selected at random. Pursuant to California Penal Code Section 326.5(o), as used in this Division, the game of bingo shall include cards having numbers or symbols which are concealed and preprinted in a manner providing for distribution of prizes. The winning cards shall not be known prior to the game by any person participating in the

playing or operation of the bingo game. All provisions of this division apply to the sale, use and redemption of such cards.

(b) and (c) - No changes.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
