AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 7 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 97.0203, RELATING TO APPLICATIONS FOR APPROVAL OF FACILITIES FOR FINANCING UNDER THE CITY OF SAN DIEGO ECONOMIC DEVELOPMENT REVENUE BOND LAW.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 7 of the San Diego Municipal Code be and it is hereby amended by amending Section 97.0203 to read as follows:

SEC. 97.0203 APPLICATIONS FOR APPROVAL

First and second paragraphs and (a), (b), (c), (d) and (e) - NO CHANGE.

Application evaluations will also consider the potential adverse effect, if any, that financing under this article would have on existing San Diego area firms. The purpose of such review is to preclude placing local firms at a competitive disadvantage by issuing bonds for an applicant.

Last paragraph - No change.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
