## ORDINANCE NUMBER 0- 15817 (New Series)

Adopted on SEP 13 1982

AN ORDINANCE INCORPORATING LOTS 1 THROUGH 16 AND 31 THROUGH 48, BLOCK 155, UNIVERSITY HEIGHTS, D'HEMECOURT MAP AMENDED (APPROXIMATELY 2.7 ACRES), LOCATED ON THE SOUTH SIDE OF HOWARD AVENUE BETWEEN 30TH AND OHIO STREETS, IN THE PARK NORTH-EAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12889, APPROVED JULY 7, 1930 AND ORDINANCE NO. 11534 (NEW SERIES), ADOPTED APRIL 4, 1975 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. That Lots 1 through 16 and 31 through 48, Block 155, University Heights, D'Hemecourt Map Amended (approximately 2.7 acres), located on the south side of Howard Avenue between 30th and Ohio Streets in the Park North-East Community Plan Area, in the City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3527.1, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 12889, approved July 7, 1930, and Ordinance No. 11534 (New Series), adopted April 4, 1975, of the ordinances of The City of San Diego be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no

building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
