AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2, DIVISION 3, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 102.0302, RELATING TO PARCEL MAPS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 3, of the San Diego Municipal Code be, and the same is hereby amended by amending Section 102.0302, to read as follows:

SEC. 102.0302 TENTATIVE MAP AND TENTATIVE PARCEL MAP - DEPOSIT SCHEDULE

Prior to, or in conjunction with, the submission of a tentative map or tentative parcel map to the Planning Department for processing, the subdivider shall pay to the City, a deposit or fee to cover City cost therefor. The amount of the deposit or fee shall be established by resolution of the City Council and filed in the office of the City Clerk as part of the City's "Ratebook of Fees and Charges"; provided, however, that if said deposit as designated therein is insufficient to cover the actual costs, the subdivider shall be required to make additional deposits with the City which, in the opinion of the Planning Director, will be sufficient to cover such costs and provided further that any portion of said deposits not used to cover the actual costs of the City in processing a

tentative map will be returned to the subdivider. The schedule requires a deposit for all subdivisions, a deposit for parcel maps in multi-family, industrial or commercial zones and a fee for parcel maps in single-family and agricultural zones.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
