AN ORDINANCE AMENDING CHAPTER II, ARTICLE 3 OF  
THE SAN DIEGO MUNICIPAL CODE BY ADDING DIVISION  
18 (RULE XVII), SECTION 23.1801 RELATING TO  
REVIEW OF CONTRACTS FOR SERVICE.

WHEREAS, The City Manager is empowered by Section 28 of the  
Charter of The City of San Diego to employ experts or  
consultants to perform work or give advice; and

WHEREAS, The Civil Service Commission is empowered by  
Section 117 of the Charter of The City of San Diego to exempt  
from the classified service for a specified period of temporary  
service, persons employed in position for expert professional  
temporary service; and

WHEREAS, it is the responsibility of the Civil Service  
Commission pursuant to Section 118 of the Charter of The City of  
San Diego to recommend to the City Council all rules and  
amendments thereto for the government, supervision and control  
of the classified service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as  
follows:

Section 1. That Chapter II, Article 3, of the San Diego  
Municipal Code be and the same is hereby amended by adding  
Division 18 (Rule XVII), Section 23.1801 to read as follows:

DIVISION 18

CONTRACTS FOR SERVICES


SEC. 23.1801 REVIEW OF CONTRACTS FOR  
SERVICES [Rule XVII of the Rules  
of the Civil Service Commission.]

All contracts for services shall be reviewed by  
the Civil Service Commission prior to execution to  
ensure compliance with the personnel-related  
provisions of the City Charter, Municipal Code, and  
Civil Service Commission Rules and Regulations.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.
