AN ORDINANCE AMENDING CHAPTER X, ARTICLE 1, DIVISION 5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 101.0502 RELATING TO ZONE VARIANCE OR RECONSTRUCTION PERMIT GRANTED BY ZONING ADMINISTRATOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 1, Division 5 of the San Diego Municipal Code be, and it is hereby amended by amending Section 101.0502 to read as follows:

- SEC. 101.0502 ZONE VARIANCE OR RECONSTRUCTION PERMIT GRANTED BY ZONING ADMINISTRATOR.
  - A. APPLICATION FORM AND CONTENT

    (No amendment to this subsection.)
  - B. HEARING BEFORE THE ZONING ADMINISTRATOR-- PROCEDURE
  - 1. An advertised public hearing shall not be required when the application is for limited relief in the case of:
    - a. Modification of distance or area regulations, provided such modification does not exceed 20 percent of required front, side or rear yards, nor exceed ten percent of maximum lot coverage regulations;
      - b. Modification of distance or area

regulations for property located in an area designated by the City Council as a "Neighborhood Improvement Area" during such time as rehabilitation activities are in progress, provided such modifications do not exceed 50 percent of required front, side or rear yard, nor exceed 20 percent of maximum lot coverage regulations, or the modifications would conform to existing building lines;

- c. Tract real estate offices, model homes, and signs in connection therewith, provided that no such variance shall be granted for a period of more than one year;
- d. Additions to structures which are nonconforming as to side yard, rear yard, or lot coverage, provided the additions shall meet the requirements of the zoning regulations affecting the property; or
- e. Walls or fences to exceed heights permitted by the zoning regulations.
