AN ORDINANCE AMENDING CHAPTER III, ARTICLE 3, DIVISION 16 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 33.1620, RELATING TO CIRCUSES, CARNIVALS, RODEOS OR SIMILAR ENTERTAINMENT OR EXHIBITIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter III, Article 3, Division 16 of the San Diego Municipal Code be, and the same is hereby amended by amending Section 33.1620 to read as follows:

SEC. 33.1620 CIRCUS, CARNIVAL, RODEO - REGULATED

It shall be unlawful for any person, firm or corporation to conduct, operate or maintain any circus, carnival, rodeo or similar entertainment or exhibition at any single location or address in The City of San Diego for any period of time or periods of time in excess of a total of fifteen (15) days within any six (6) months period of time.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
