AN ORDINANCE REMOVING A 60-FOOT-WIDE BUILDING SETBACK ALONG THE NORTH PROPERTY LINE OF LOT 1, CITY OF SAN DIEGO INDUSTRIAL PARK, UNIT 1, MAP 3978

WHEREAS, the owner of Lot 1, City of San Diego Industrial Park, Unit 1, Map 3978, has requested the removal of a 60-foot-wide building setback along the north property line of said lot; and

WHEREAS, the setback was established in 1958 to accommodate a future railroad spur anticipated for the area; and

WHEREAS, it has now been determined that the railroad spur will no longer be constructed in this location and the setback is no longer needed; and

WHEREAS, on August 19, 1982, the Planning Commission recommended in favor of the removal of the setback; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to Section 101.0604 et seq. of the San Diego Municipal Code the 60-foot-wide building set back on Lot 1, City of San Diego Industrial Park, Unit 1, Map 3978, is hereby removed.
- 2. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this ordinance, attested by him under seal, to be recorded in the office of the County Recorder.

That this ordinance shall take effect and be in force on the thirtieth day from and after its passage.
