AN ORDINANCE AMENDING ORDINANCE NO. O-15780 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-15780-1 AND 00-15780-2, AS AMENDED AND ADOPTED THEREIN, BY AMENDING SECTION 2, SUBSECTION II.1, "TRANSIENT OCCUPANCY TAX FUND" TO INCLUDE A NEW PROGRAM (91509) ENTITLED "SPIRIT OF '76 BOOSTER CLUB" AND PROVIDE THE SUM OF \$1,000 FOR SAID PROGRAM.

WHEREAS, on November 24, 1982, the Council Committee on Public Services and Safety unanimously approved an allocation of \$1,000 of Transient Occupancy Tax Funds to the Spirit of 76 Booster Club; and

WHEREAS, said funds are to be used to help send the Patrick Henry Marching Band to the 1983 Tournament of Roses Parade and promote the City of San Diego; and

WHEREAS, said funds will be provided by a transfer from the line item entitled "Reimburse General Fund-Administration Program" of the Special Promotional Programs and if the sum currently earmarked as a reserve against a Holiday Bowl deficit is not needed, the \$1,000 will be "returned" to the above program; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-15780 (New Series) as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO

OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" be and the same is hereby further amended by amending Documents No. 00-15780-1 and 00-15780-2, as amended and adopted therein, by amending Section 2, Subsection II.1, "Transient Occupancy Tax Fund," to include therein a new Program (91509) entitled "Spirit of '76 Booster Club."

Section 2. That the aforesaid Section 2, Subsection II.1, be and it is hereby further amended by amending the language of the second full paragraph of narrative to read as follows:

Any of the \$25,000 which is appropriated to offset a deficit in the Holiday Bowl Game but which is not needed for that purpose is hereby authorized to be transferred as follows:

- (1) The first \$24,000 to the Economic Development Corporation for the purpose of advertising in Fortune Magazine; and
- (2) The remaining \$1,000 to Reimburse General Fund - Administration Costs.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$1,000 within the Transient Occupancy Tax Fund 10223 from Program 91557, Reimburse General Fund - Administration Costs to Program 91509, Spirit of '76 Booster Club, said sum to be used for the purpose of sending the Patrick Henry Marching Band to the 1983 Tournament of Roses Parade and promoting The City of San Diego, pursuant to the terms and conditions of the letter agreement between The City of San Diego and the Spirit of '76 Booster Club, on file in the


office of the City Clerk as Document No. **RR-257597**

Section 4. That Section A-5 of Council Policy 100-3, which requires that a funded organization be a nonprofit corporation be and the same is hereby waived for Program 91509, Spirit of '76 Booster Club.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.
