AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 0-15453 (NEW SERIES), ADOPTED MARCH 25, 1981, INCORPORATING A PORTION OF SECTION 6, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, AND AMENDING SECTION 1 OF ORDINANCE NO. O-15569 (NEW SERIES), ADOPTED SEPTEMBER 17, 1981, INCORPORATING THE WESTERLY 250 FEET OF THE NORTHERLY 400 FEET OF THE SOUTHEAST 1/4 OF THE SOUTHWEST 1/4 OF SECTION 6. TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8858 (NEW SERIES), ADOPTED JULY 18, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

WHEREAS, a request has been received to extend the time on Ordinance No. O-15453 (New Series), adopted March 25, 1981, and Ordinance No. O-15569 (New Series), adopted September 17, 1981; and

WHEREAS, Section 1 of Ordinance No. 0-15453 (New Series) provided that the "R-1-5" Zone would attach if a final map or maps were recorded on or before March 25, 1983 and Section 1 of Ordinance No. 0-15569 (New Series) provided that the "R-1-5" Zone would attach if a final map or maps were recorded on or before September 17, 1983; and

WHEREAS, the requested extension of time will permit the successful conclusion and implementation of the zoning pattern heretofore approved by the Planning Commission; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 1 of Ordinance No. 0-15453 (New Series), adopted March 25, 1983, and Section 1 of Ordinance No. 0-15569 (New Series), adopted September 17, 1983, are hereby amended to read as follows:

Section 1. That in the event that a Portion of Section 6, Township 14 South, Range 2 West, S.B.B.M. and the Westerly 250 feet of the Northerly 400 feet of the Southeast 1/4 of the Southwest 1/4 of Section 6, Township 14 South, Range 2 West, S.B.B.M., in the City of San Diego, California, within the boundary of the district designated "R-1-5" on that certain Zone Map Drawing No. B-3577, is subdivided and a final subdivision map or maps thereof duly submitted to the City on or before March 25, 1987, and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0407 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into R-1-5 Zone, as described by Section 101.0407 of the San Diego Municipal Code, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3577, filed in the office of the City Clerk as Document No. 788695 Said zoning shall attach only to those areas included in the subdivision map or maps recorded as provided in this section.

Section 2. This ordinance shall take effect and be in

force on the thirtieth day from and after its passage.
