AN ORDINANCE AMENDING ORDINANCE NO. O-15780 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-15780-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF COUNCIL DISTRICT 4 (024), ONE (1) COUNCIL REPRESENTATIVE II POSITION; EXEMPTING SAID POSITION FROM THE CLASSIFIED SERVICE, AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, Council District 4 has requested the addition of one (1) Council Representative position to its personnel allocation; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission has reviewed this request on May 12, 1983, and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, no additional funds are required to be transferred in that the requested position shall be funded from salary savings; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said reclassification; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-15780 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1982-83 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-15780-1, as adopted and amended therein, by adding to the personnel authorization schedule of Department 024, Councilmanic District 4, one (1) Council Representative II position.

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon favorably by the Civil Service Commission on May 12, 1983, the Council Representative II position is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rate 7.0 of the Table of Classifications and Standard Salary Rates under Managerial Category, identified as Exhibit C to Ordinance No. 15750 (New Series), be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its passage after two (2) public hearings pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.

This ordinance amends the Annual Appropriation Ordinance to add one (1) Council Representative II position to the authorized personnel schedule of Council District 4, Department 024. It also exempts said position from the Classified Service, after review and favorable comment by the Civil Service Commission as required by Charter section 117(a)17, and establishes a salary rate for the position.
