BE IT FURTHER RESOLVED, that the expenditure from CIP 23-661.1 Montgomery-Waller Community Park-Development-Phase III, not to exceed \$122,500.00 from Park Service District Funds, and \$464,302.00 from Capital Outlay Fund 30245 of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
