Linda E. Logan	City Attorney	\$ 485	Ms. Logan is an Intermediate Typist. One year ago she earned a partial award of \$410 for her suggestion to utilize a simplified method for purging cards and cases. One year's experience has shown a savings of \$2,999. This is the remainder of her award.
Edward J. Zitter	Police	\$ 190	Mr. Zitter is a Police Sergeant. One year ago he earned a partial award of \$160 for his suggestion to improve the filing system for juvenile offenders' records by prefacing the number with the year of birth. One year's experience has shown a savings of \$1,166. This is the remainder of his award.
Nicholas E. Haluskey	Building Inspection	\$ 155	Mr. Haluskey is a Senior Building Inspector. One year ago he earned a partial award of \$150 for his suggestion to combine field inspection forms IN-869 and IN-870 to reduce paperwork. One year's experience has shown a savings of \$3,079. This is the remainder of his award.
John E. Scott	General Services	\$ 110	Mr. Scott is a Communications Technician in the Communications and Electrical Division. He suggested that circuit breakers in Altec amplifiers be replaced with fuses. This is expected to save \$372 in the first year in costs for time and material.
Valerie S. Smith	Risk Management	\$ 70	Ms. Smith was a Senior Typist. One year ago she earned a partial award of \$65 for her suggestion to develop a cross-reference index file for liability claims by location. One year's experience has shown a savings of \$1,350. This is the remainder of her award.
