Michael A. Stephenson	Fire	\$ 20	Mr. Stephenson is a Fire Engineer. He suggested that a Fire Engineer Handbook which he developed be used as a training aid. This material is presently available for checkout at the Training Division library. Although savings were difficult to identify, this was considered to be a significant operational improvement.
David C. Paules	Fire	\$ 20	Mr. Paules is a Fire Captain. He suggested that dook locks on fire apparatuses be modified to eliminate the possibility of personnel being locked out. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Robert N. Edgett	Police	\$ 20	Mr. Edgett is a Police Officer. He suggested that non-skid tape and mats be installed in area station showers. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Kenneth Campoy	General Services	\$ 20	Mr. Campoy is a Carpenter in the Buildings Division. He suggested that the emergency eye wash be replaced with a fresh supply. Although savings were difficult to estimate, this was considered to be a significant safety improvement.
Pamela S. Allegra	Personnel	\$ 20	Ms. Allegra is an Intermediate Clerk. She suggested that scratch paper used at Civil Service examinations no longer be retained. Although savings were difficult to identify, this was considered to be a significant operational improvement.
