
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to issue one check in the amount of \$35,000, made payable to "Connie Reid, Horace Charles Wells, and their attorney, Gerald S. Davee," in full settlement of the lawsuit and of all claims.
