1. DE NARDI AND WOOD for Item 1, eight (8) each Metal Line Construction Bodies at a cost of \$3,735.00 each; Item 4, one (1) each Flat Bed Body, 21 ft., at a cost of \$1,145.00; Item 6, one (1) each Flat Bed Body, 12 ft., at a cost of \$689.00; and Item 7, three (3) each Dump Bodies and Hoist, 3 yard, at a cost of \$2,787.00 each; for a total cost of \$40,075.00; terms 1% 20 days plus sales tax.
2. UTILITY BODY COMPANY for Item 2, three (3) each Service and Maintenance Bodies at a cost of \$1,500.00 each; for a total cost of \$4,500.00; terms net 30 days plus sales tax.
3. D & H TRUCK EQUIPMENT, INC. for Item 3, one (1) each Service and Maintenance Body at a cost of \$1,529.00; terms net 30 days plus sales tax.
4. BEBCO for Item 5, one (1) each Flat Bed Body, 10.75 ft., at a cost of \$816.00; terms net 10 days plus sales tax.
