


RESOLUTION No. R-255630 (R-82-997)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of LANDSCAPE IRRIGATION SPECIALISTS, INC., a corporation, for the CONSTRUCTION OF PARADISE HILLS/BAY TERRACES COMMUNITY ATHLETIC AREA - PHASE II in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00260.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$16,670.00 from PSD Fund 11700 to CIP 23-386, Paradise Hills/Bay Terraces Community Athletic Area.
