RESOLUTION NUMBER R- 255635

Adopted on JAN 11 1982

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to GILMAN DRIVE from Lots 50 and 51 of La Jolla Scenic Heights, Map 4382, now known as Parcel 3 of Parcel Map 3377, filed in the office of the County Recorder; and

WHEREAS, STUART O. BAESEL and BETSEY C. BAESEL, Co-Trustees, U.T.D. October 3, 1979, have requested that the City revest these abutter's rights of access in and to Gilman Drive; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, said abutter's rights of access were acquired at no cost; and

WHEREAS, the access rights have only a nominal value under the circumstances and STUART O. BAESEL and BETSEY C. BAESEL, Co-Trustees, U.T.D. October 3, 1979, have paid all City costs in connection with processing the matter of revestment; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of

which is on file in the office of the City Clerk as Document No. RR- 255635 , quitclaiming to STUART O. BAESEL and BETSEY C. BAESEL, Co.-Trustees, U.T.D. October 3, 1979, the revestment of those abutter's rights of access in and to Gilman Drive from Parcel 3 of Parcel Map 3377, as more particularly described in said quitclaim deed.

2. That the City Clerk shall cause said quitclaim deed, and a certified copy of this resolution, to be recorded in the Office of the County Recorder.
