

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with MARC TARASUCK, AIA & ASSOCIATES, to prepare plans and specifications for the development of a vest pocket park in the Gaslamp Quarter Historic District, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR- 255638 .

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$10,750 for said services representing a basic fee of not to exceed \$8,250, plus not to exceed \$2,000 as reimbursable expenses for soil tests, and not to exceed \$500 for miscellaneous additional expenses, is hereby authorized.
