RESOLUTION NUMBER R- 255643

Adopted on JAN 11 1982

WHEREAS, on October 5, 1981, the City Council adopted Resolution No. 255145 whereby the Manager was authorized to issue a Request for Proposals for hotel development on the Torrey Pines Mesa; and

WHEREAS, SANDAG, acting as the Airport Land Use Commission, raised concerns regarding the consistency of the project with the Comprehensive Land Use Plan-NAS Miramar; and

WHEREAS, the City Council adopted Resolution No. 255475 on December 8, 1981 whereby the project was modified to address SANDAG's concerns; and

WHEREAS, the SANDAG Board, acting as the Airport Land Use Commission, held a public hearing on December 21, 1981 and resolved that certain changes to the project would make it consistent with the Comprehensive Land Use Plan and safe for the public; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to revise the Request for Proposals to specify that the project shall be limited to a

maximum of 400 new rooms and coverage of the site by buildings shall be limited to a maximum of 40%.
