RESOLUTION NUMBER R- 255648

Adopted on JAN 11 1982

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to FRIARS ROAD from a portion of Pueblo Lot 1109; and

WHEREAS, CONROCK COMPANY has requested that the City revest these abutter's rights of access in the property to allow access to Friars Road for the subdivision to be known as Rio Vista Center; and

WHEREAS, said abutter's rights of access were acquired at no cost and only have a nominal value under the circumstances; and

WHEREAS, Conrock Company has paid all City costs in connection with processing the matter of quitclaiming the access rights, and there will be no charge for the revestment of access rights; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 255648 -/, quitclaiming to CONROCK COMPANY the

revestment of those abutter's rights of access in and to FRIARS ROAD from a portion of Pueblo Lot 1109, as more particularly described in said quitclaim deed.

2. That the City Clerk shall cause the quitclaim deed and a certified copy of this resolution to be recorded in the office of the County Recorder.
