BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is hereby authorized and directed to execute, for and on behalf of The City of San Diego, an agreement to provide for the installation of a traffic signal at the intersection of Pomerado Road and Escala Drive, pursuant to the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-255680.

BE IT FURTHER RESOLVED, that The City of San Diego will reimburse AVCO COMMUNITY DEVELOPERS INC., a California corporation, an amount equal to 50 percent of the cost of the installation, but not to exceed the sum of \$45,000.00, which sum shall be paid from fund CIP 61-001, and payment is hereby authorized to be paid upon completion of the installation.

BE IT FURTHER RESOLVED, that Subdivision Review Board Resolution No. 3158, is hereby amended to provide that AVCO COMMUNITY BUILDERS shall reimburse The City of San Diego for any amounts paid pursuant to the preceding paragraph prior to the acceptance by the City Council of the final map of Montelena Townhomes, TM 01-243-0.
