RESOLUTION NUMBER R- 255684

Adopted on JAN 18 1982

WHEREAS, in July 1979, the Mayor appointed a Committee for Transportation and Parking in Centre City to review and provide recommendations to the City Council for solutions to transportation, circulation and parking problems in the central area; and

WHEREAS, the Committee consisted of representatives from San Diegans Incorporated, San Diego Transit Corporation, Centre City Development Corporation, Gaslamp Quarter, Central City Association, Chamber of Commerce, San Diego Unified Port District and the Metropolitan Transit Development Board; and

WHEREAS, the Committee prepared a final report dealing with these problems and presented said report to the City Council on May 4, 1981; and

WHEREAS, the report made several recommendations, including the appointment of a citizen's committee to advise the Mayor and Council periodically on the status of transportation and parking in Centre City; and

WHEREAS, it was also recommended that this committee be provided with an independent consultant and that reports be submitted to the City Council as required, but at least annually; and

WHEREAS, the recommendations of the Committee have been reviewed and, in conformance with the information contained in

the City Manager's Report No. 81-455, dated December 16, 1981, it is recommended that the citizen's committee be formed and supported by existing staff; NOW, THEREFORE,


BE IT RESOLVED by the City Council of The City of San Diego that the Mayor is requested to appoint pursuant to Charter section 43(b), an Advisory Committee for Transportation and Parking in Centre City from various recognized groups as identified in City Manager's Report No. 81-455, dated December 16, 1981.

BE IT FURTHER RESOLVED that the City Manager be and he is hereby authorized to provide, within budgetary limitations, necessary staffing for the Committee's operations.

BE IT FURTHER RESOLVED that the City Manager be and he is hereby directed to seek outside funding for consultant services for this committee from interested groups enumerated in the Manager's Report to the Rules Committee, No. 81-455, dated December 16, 1981.
