

RESOLUTION NUMBER R- 255702

Adopted on JAN 25 1982

WHEREAS, the Fieldstone Company has obtained approval of the subdivision of certain real property covered by tentative subdivision map No. TM 78-377; and

WHEREAS, condition No. 21 of Resolution No. 2296 of the Subdivision Board approving the tentative map requires that the subdivider obtain a letter of school availability from the San Diego Unified School District prior to approval of the final map by the City Council; and

WHEREAS, the San Diego Unified School District is unable to provide a letter of school availability at this time due to their need to reevaluate student-generation factors; and


WHEREAS, The Fieldstone Company has requested that condition No. 21 of Subdivision Board Resolution No. 2296 be amended to provide that a letter of school availability shall be provided prior to the issuance of any building permits for construction of any dwelling units within the area covered by TM 78-377; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that, upon the request of The Fieldstone Company, subdivider of the real property included within TM 78-377, condition No. 21 of Subdivision Board Resolution No. 2296 is hereby amended to read as follows:

20. Prior to the issuance of any building permits,
the Subdivider shall submit a Letter of School Availability
from the San Diego Unified School District.
