WHEREAS, the Fieldstone Company has obtained approval of the subdivision of certain real property covered by tentative subdivision map No. TM 78-377; and

WHEREAS, condition No. 21 of Resolution No. 2296 of the Subdivision Board approving the tentative map requires that the subdivider obtain a letter of school availability from the San Diego Unified School District prior to approval of the final map by the City Council; and

WHEREAS, the San Diego Unified School District is unable to provide a letter of school availability at this time due to their need to reevaluate student-generation factors; and

20. Prior to the issuance of any building permits, the Subdivider shall submit a Letter of School Availability from the San Diego Unified School District.
