

RESOLUTION NUMBER R- 255707

Adopted on JAN 25 1982

WHEREAS, Section 8330 et seq. of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where the portion of the street to be vacated is excess width of right-of-way not required for street or highway purposes; and

WHEREAS, the owner of the property abutting the cul-de-sac has requested the vacation of a portion of Scheidler Way, south of Camino Del Rio South, adjacent to Lot 1 of Nagel Tract Unit No. 2, Map 4737; and

WHEREAS, the portion of street to be vacated is excess width of right-of-way; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access or will be accessible because of the nature of the lot created with the approval on this date JAN 25 1982; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That a portion of Scheidler Way, south of Camino Del Rio South, adjacent to Lot 1 of Nagel Tract Unit No. 2, Map 4737, as more particularly shown on Drawing No. 15446-B on file in the office of the City Clerk as Document No. RR- 255707, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.

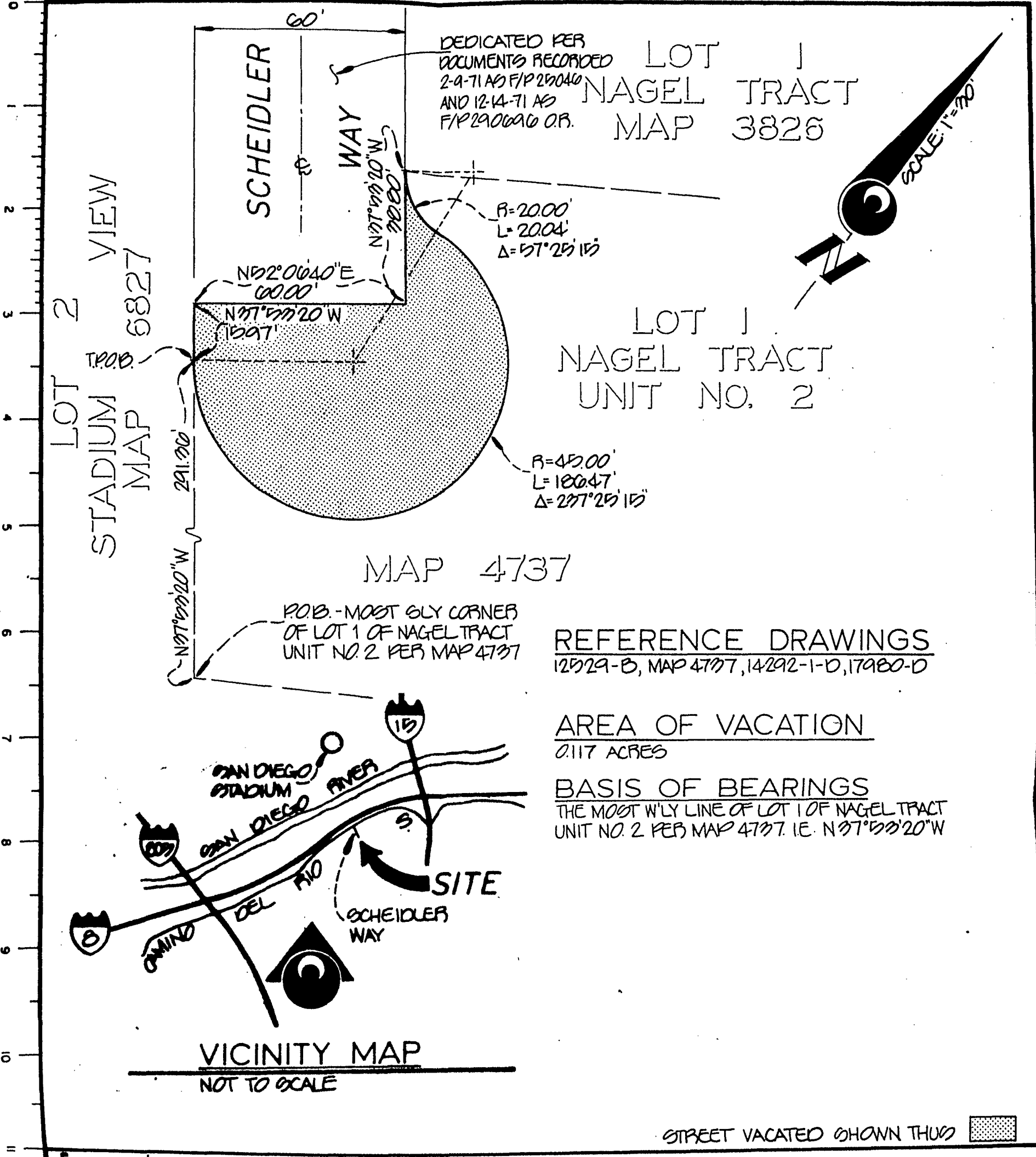

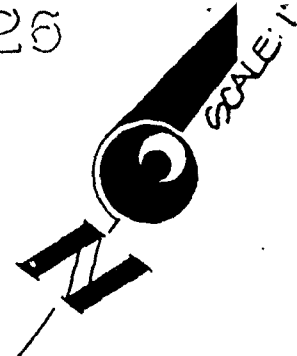

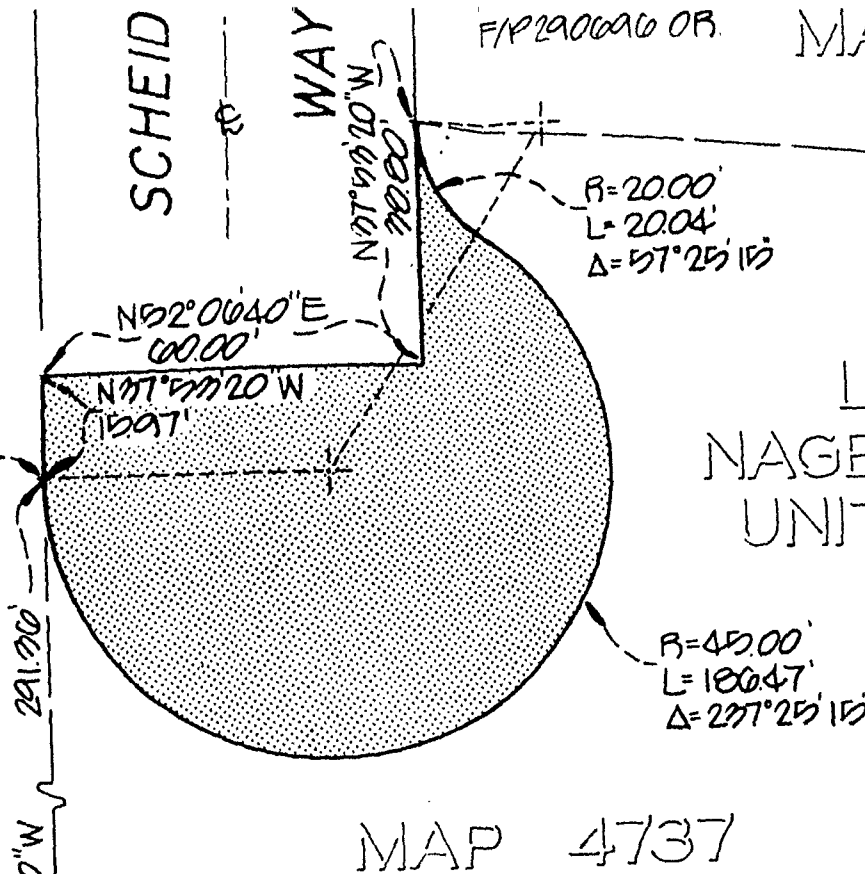
BASIS OF BEARINGS

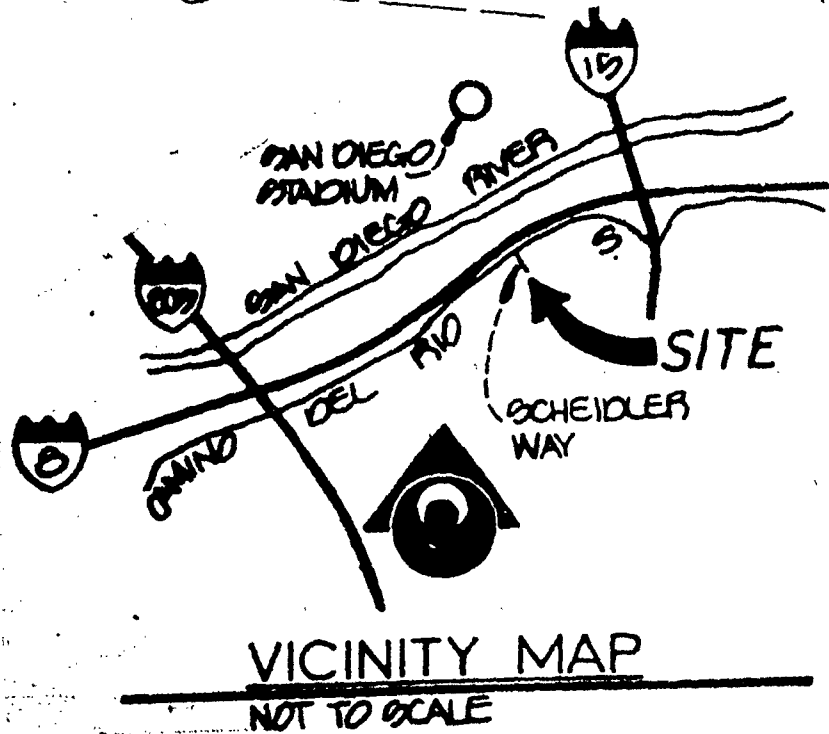
