WHEREAS, CHILCOTE, INC., a California corporation, has requested an exchange of drainage easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the acceptance by the City Manager of that deed of CHILCOTE, INC., a California corporation, executed in favor of The City of San Diego, bearing date of September 16, 1981, conveying to said City drainage easements in Lots 23, 24, 25, 32, 33 and 43 of Del Cerro Shores Unit No. 1, Map 9704, as more particularly described in said deed, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- **255709-2**, quitclaiming to CHILCOTE, INC., a California corporation, all of the City's right, title and interest in the drainage easements in Lots 23, 24, 25, 32, 33 and 43 of Del Cerro Shores Unit No. 1, Map 9704, as more particularly described in said deed.

3. That the City Clerk shall cause a certified copy of this resolution, with deed, attested by him under seal, to be recorded in the office of the County Recorder.
