RESOLUTION NUMBER R- 255711

Adopted on JAN 25 1982

WHEREAS, SCRIPPS CLINIC AND RESEARCH FOUNDATION, a California corporation, has requested an exchange of drain and water easements; and

WHEREAS, the present easement alignment conflicts with the development of the property; and

WHEREAS, the exchange will relocate the easements and allow development without encroaching on City easements; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the acceptance by the City Manager of that deed of SCRIPPS CLINIC AND RESEARCH FOUNDATION, a California corporation, executed in favor of The City of San Diego, bearing date of August 26, 1981, conveying to said City drain and water easements in Parcels 1 and 2 of Parcel Map 11723, as more particularly described in said deed, is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 255711-2 quitclaiming to SCRIPPS CLINIC AND RESEARCH FOUNDATION, a California corporation, all of the City's right, title and interest in the drain and water easements in Parcels 1 and 2 of Parcel Map 11723, as more particularly described in said deed.

3. That the City Clerk shall cause a certified copy of this resolution, with deed, attested by him under seal, to be recorded in the office of the County Recorder.
