That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, the Fourth Amendment to The Agreement with the San Diego Gaslamp Quarter Association, Inc., to continue the operation of a CDBG funded program, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 255715 .

BE IT FURTHER RESOLVED, that the transfer of \$18,100 from 1981 CDBG contingency fund 18517, department and organization 5994/9401 to Gaslamp Quarter Community Development Program CDBG fund 18517, department and organization 5987/8702; and the expenditure of \$18,100 from the Gas Lamp Quarter Community Development Block Grant Fund, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
