RESOLUTION NUMBER R- 255719

Adopted on JAN 25 1982

WHEREAS, a portion of Martinez Street between the westerly line extended of Lot 3 and the easterly line extended of Lot 5, Block 5, of Golden Park, Map 958, which portion is approximately 150 feet in length, is a dedicated 30-foot right-of-way improved with a 15-foot-wide strip of asphalt paving; and


WHEREAS, in May, 1981, a landslide removed a portion of the street improvements making through traffic impractical; and

WHEREAS, in order to protect the public health, safety and general welfare, it is necessary and desirable to close said portion of Martinez Street to motor vehicular traffic pursuant to Section 21101(a) of the Motor Vehicle Code of the State of California; NOW, THEREFORE,

BE IT RESOLVED, that the above-described portion of Martinez Street, as more particularly described in Engineer Drawing No. 20277-D, a copy of which is on file in the office of the City Clerk as Document No. RR- 255719, is hereby closed to motor vehicular traffic.

BE IT FURTHER RESOLVED, that this closing shall not constitute a vacation of said right-of-way and that the City Council reserves the right in the future to reopen the street to motor vehicles in the event a determination is made that the street is appropriate for use by motor vehicles.
