
WHEREAS, on December 8, 1976, the City Council adopted Resolution No. 217252 directing City staff to initiate procedures to donate certain City-owned property and property rights (easements) to the State of California for addition to the Torrey Pines Reserve; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Mayor and the City Clerk are hereby authorized and empowered to execute a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR- 255758, conveying the City's right to enforce the provisions of an open space easement granted to City on portions of Lots 6, 7 and 8, Torrey Pines Science Park, which easements cumulatively cover approximately 13 acres, to the STATE OF CALIFORNIA, for utilization consistent with the development and use of the Torrey Pines Reserve.
