BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street, slope and drain easement deeds of GLEN R. SIMS and MYRTLE SIMS, husband and wife; VISTA CIELO, a partnership; and DEGAN/HALL DEVELOPMENT COMPANY, a California corporation, executed in favor of The City of San Diego, bearing dates of April 15, 1981, December 5, 1978, and August 21, 1981, respectively, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 255759-1, RR- 255759-2, RR- 255759-3 and RR- 255759-4, granting to said City easements for street, slope and drain easements in Lots 22 through 29, Block 1, Paradise Crest Map 1558, Lots 47 and 48, Vista Del Cielo, Map 8932, and a portion of Quarter Section Lot 78 Rancho De La Nacion, Map 166, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for a public street is hereby dedicated as and for a public street, and the same is hereby named WOODMAN STREET.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
