

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of those street and flowage easement deeds of PLAYA BLANCA ASSOCIATES, a general partnership, executed in favor of The City of San Diego, bearing date of January 26, 1981, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 255762 -1 and RR- 255762-2, granting to said City street and flowage easements affecting portions of the Northwest Quarter of the Northeast Quarter of Section 28, Township 18 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed for public street purposes is hereby dedicated as and for public streets, and Parcel 1 is hereby named NINETEENTH STREET, Parcel 2 is hereby named AVENIDA DE LA MEXICO, and Parcel 3 is hereby named CERRISSA STREET.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
