
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That this Council hereby approves the City Manager's recommendations in Manager's Report No. 81-416, dated October 30, 1981, to implement three revised park and recreation fees for adult softball fields, basketball/volleyball courts and children's swimming pool admission, as amended by the Public Facilities and Recreation (PF&R) Committee, on November 4, 1981, to provide for the potential of reduced fees for basketball/volleyball court users, if this group is successful in assuming City costs before July 1, 1982.
