WHEREAS, the Planning Commission of The City of San Diego held a public hearing on November 19, 1981, to consider proposed amendments to the La Jolla Shores Precise Plan; and

WHEREAS, the La Jolla Shores Precise Plan was adopted by the City Council on November 2, 1971, to establish guidelines for the development of a future planned district to maintain the quality of existing development and conserve the natural amenities of the La Jolla Shores Area; and

WHEREAS, the La Jolla Shores Precise Plan was amended by the City Council on March 11, 1976, to create Tracts G, H and I, westerly of Gilman Drive; and

WHEREAS, on May 13, 1980, the City Council directed the Planning Department to prepare a survey of all vacant tracts of land within the La Jolla Shores Precise Plan area and to prepare revised recommendations for each site, as necessary, based on current information; and

WHEREAS, on November 3, 1980, the City Council directed the Planning Department to develop amendments to the La Jolla Shores Precise Plan based upon the recommendations of the vacant land survey and to combine the amendments with the preparation of the La Jolla/La Jolla Shores Local Coastal Program; and

WHEREAS, the proposed amendments would further the goals of the Precise Plan by revising the descriptions and recommendations for Tracts A through I and Parcels 6 and 7 to reflect

existing conditions within the community; and


WHEREAS, the proposed amendments would provide consistent language for both the La Jolla Shores Precise Plan and La Jolla Shores Planned District ordinances; and

WHEREAS, the proposed amendments have been developed to respond to the goals, policies and requirements of the California Coastal Commission's conditions of approval of the La Jolla/La Jolla Shores Land Use Plan segment of The City of San Diego's Local Coastal Program; and

WHEREAS, the City Council has held a concurrent public hearing consistent with City Council Policy No. 600-7, to consider an amendment to the General Plan in order to retain consistency between said Precise Plan amendments and the General Plan map; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego, that it hereby approves and adopts the La Jolla Shores Precise Plan amendments and amendment to the Progress Guide and General Plan for The City of San Diego.
