WHEREAS, said Addendum has been developed to respond to the policies, goals and requirements of the California Coastal Act of 1976; and

WHEREAS, said Addendum will amend portions of the existing adopted Mission Beach Precise Plan; and

WHEREAS, this City Council has also reviewed the Mission Beach Local Coastal Plan Addendum and heard all public testimony; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


