WYLIE CONSTRUCTION COMPANY for the Point Loma Wastewater Treatment Facilities Accelerated Projects Construction Contract C-2, Schedule A: Scum Removal Facilities, Odor Removal Facilities, and Sedimentation Basins 7 and 8, said contract having been filed in the office of the City Clerk as Document No. A00149 be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$40,364 be and the same are hereby approved.
