RESOLUTION NUMBER R- 255799

Adopted on FEB 8 1982

WHEREAS, the Equal Rights Amendment states that equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex; and

WHEREAS, the Congress shall have the power to enforce, appropriate legislation, the provisions of this article; and


WHEREAS, this amendment shall take effect two years after the date of ratification; and

WHEREAS, this amendment to the Constitution of the United States is pending before several state legislatures for ratification; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego endorses the Equal Rights Amendment and urges the remaining states to ratify that amendment.
