RESOLUTION NUMBER R-255802

Adopted on FEB 9 1982

WHEREAS, the Salary Setting Commission (herein called "Commission") of The City of San Diego, pursuant to Sections 12.1 and 41.1 of the Charter, conducted extensive research and held a series of public hearings for the purpose of ascertaining facts sufficient to establish salary levels for recommendation to the Council for adoption by ordinance; and

WHEREAS, pursuant to the Charter requirement, the Commission is required to present its recommendations to the Council in public hearing on or before February 15 of every even year; and

WHEREAS, the Commission presented its recommendations as required on February 9, 1982; and

WHEREAS, the Commission recommended a two-step increase in annual compensation for City Council members, the first step of \$25,750 to be established and incorporated in the fiscal year 1983 Salary Ordinance, to be effective July 1, 1982 and the second step of \$30,000 to be established and incorporated in the fiscal year 1984 Salary Ordinance, to be effective July 1, 1983;  
NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the determination and recommendations of the Salary Setting Commission be and they are hereby approved and adopted, with the

proviso that the second step recommended by the Salary Setting Commission be returned to Council for further review and consideration prior to July 1, 1983.

BE IT FURTHER RESOLVED, that the City Attorney be, and he is hereby directed to bring forward to the City Council, pursuant to Section 41.1 of the Charter, an ordinance setting forth the Commission's recommendations for incorporation in the Annual Salary Ordinance
