

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$427,400.00 by CHARLES NOBLE COMPANY, a corporation for the CONSTRUCTION OF POINT LOMA STOREROOM BUILDING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. A-00257.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$57,900.00 within the Sewer Revenue Fund 41506 from the Unallocated Reserve to Sewer Construction Outlay 70292, CIP 46-059, Point Loma Sewage Treatment Plant Storeroom Building.
3. That the expenditure, not to exceed \$57,900.00 from the Sewer Revenue Fund 41506, is hereby authorized to supplement funds previously authorized by Resolution No. 255075, adopted September 29, 1981 for the purpose of executing this contract and related costs.
