

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of DOROTHY S. NORMAN, executed in favor of The City of San Diego, bearing date of January 5, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 255861, granting to said City the permanent easement and right-of-way for public street purposes in a portion of the East Half of Lot 39 of Horton's Purchase in the Ex-Mission Lands of San Diego, Map No. 283, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 46TH STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
