
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of UNIVERSITY FORD is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of EIGHTY-NINE (89) POLICE CARS (Ford Fairmount with 255 C.I.D. V-8 Engine) at a cost of \$7,149.00 each, for a total of \$636,261.00; terms net 20 days, plus sales tax, less trade-in allowances as follows:
